Sub: FIR against two miscreants for escaping from police custody.

Sir,

I, SI Biswajit Biswas of Pradhan Nagar P.S. SPC do hereby lodged this written complaint against the following two accused persons namely (i) Rajkumar Rajbanshi(M/30), S/O Lt. Shib Rajbanshi of vill. Joshimall, P.S Dhulabari, Dist. Jhapa, Nepal and (ii) Ghanashyam Chowdhury (M/25), S/O Pancha Bahadur Chowdhury of vill. Ittabhatta, P.S Kakarvita, Dist. Jhapa, Nepal to the effect that last intervening night(08/05/24) at about 3.45 hrs in course of performing night mobile duty, I got an information that few miscreants were creating nuisance at Coolie Para Siliguri Junction Road in front of Saheb Vaishnav Hotel under PS Prodhannagar, Dist, Darjeeling under the influence of illicit liquor. I along with my force immediately rushed to the spot and found that few apparently looking rowdies were involved in physical fighting and uttering filthy languages within themselves being intoxicant. We could be able to apprehend two miscreants among them while rest others fled away. They disclosed their names and addresses as mentioned above then I took them into custody with an objective to submit non FIR prosecution against them u/s 34 Police Act after conducting their medical examination from Matigara Hospital. In course of taking them to Pradhannagar P.S. via Matigara Hospital by a Police vehicle, suddenly they both assaulted the force on duty and jumped out from our running vehicle at Mallaguri Service Road near NBSTC Depot, PS Proadhan nagar, Dist, Darjeeling at about 4.15 hrs. Stopping our vehicle immediately, we chased to detain them in vain. After conducting an enquiry against both of them it is learnt that they both are notorious criminals who came to Junction area under Pradhannagar PS with a plan to commit crime against property .

Hence, I pray before your kind honour to start a specific case against both of them and others for escaping from police custody after assaulting police force on duty under proper section of law and to arrange for its investigation.
