Subject - Written Complaint

Respected Sir,

I Sachin Kumar Sah, S/o - Sri Jay Narayan Sah, resident of Rajendra Nagar, Coolie Para, Ward No -1, P.O. Pradhan Nagar, P.S. Pradhan Nagar, District - Darjeeling, West Bengal, PIN - 734003, would like to state following facts before you which are as follows:

1. That today i. e. 10th May 2024, at around 8:00 AM I went to open my fooding hotel namely Ahar Hotel along with my father namely Sri Jay Narayan Sah, my brother Bikram Kumar Sah, which is situated just opposite to Anandaloke Sonocan centre in ward no .1 and we got engaged in our daily work related to our hotel along with our staffs.
2. That surprisingly three persons namely (1)Sri Hiralal Sah, who is the owner of a fooding hotel namely Bijay hotel along with his two sons namely (2)Sri Bijay Sah S/o - Hiralal Sah, and (3)Sri Abhay Sah S/o - Hiralal Sah all are resident of Ward No.1 , Collie Para, P.O & P.S. Pradhan Nagar, Dist - Darjeeling, Started abusing me and my father along with my brother without any reason.
3. On questioning them they became aggressive and started assaulting us physically and when we resisted this act then all of sudden Bijay Sah hit my father with an iron rod on his left shoulder and my father fell down on the floor.
4. That after seeing my father's condition me and my brother Bikram Sah tried to help my father as he was crying very badly as he was in immense pain also he is around 60 years of age and a senior citizen, all of sudden Son of Hiralal Sah namely Bijay Sah attacked with Iron Boti on my father's neck with a intention to kill my father but my brother Bikram Sah any how managed to save my father by placing his hand to protect my father from such attack and while saving my father my brother's hand got injured very badly.
5. That we went to Siliguri District Hospital for the treatment of my brother namely Bikram Sah and my father but the hand injury was as critical they referred my brother to NBMCH for the better treatment but when we went to NBMCH the health authority were willing to reffer my brother to Kolkata Medical College for his treatment as the injury was very critical and bleeding was not stopping.

That it is pertinent to mention here that this people have a very bad character in the society, they always indulge in fight with everyone one in the society as they say that they have good contacts no one can do anything against them. They have also good police contacts and taking the advantage of the same they are running their hotel without any Trade Licence nor food licence and they also sell Desi and foreign liquor in their hotel illegally.

That on the above facts I am praying before you to kindly register this complaint as F.I.R against all the culprits and take legal action according to penal provision of the code.
