I, Bro. Bibhudan Biswas, S/o Late Keshab Biswas, resident of Maran Atha Church , P.O. Debagram, P.S. Gangnapur, Dist. Nadia, West Bengal 741238, am the Foundation Worker of the Church namely : **All-One-in-Christ Church Fellowship, Bridal, Apostolic and Prophetic, (in Bengali which is Khristo-Jishute-Shokolei-Ek-Mondolir Shohobhagita, Bharjarupi, Prairitik O Bhababadik) .**

It is to inform you that we have many branches across the cities in India as well as in West Bengal. The Burial Ground at Chayan Para, near Ashray Giri Church, Opposite of Nag Nursing Home is our Burial Ground (we have all documents to prove our title claim) and comes under your jurisdiction.

By nature we are peace loving and law abiding citizens. It is stated that nowadays we are facing a burning problem due to some local miscreants. As on Thursday, 2nd of May 2024, we came to know from a reliable source that an aged lady with some local hooligans forcefully trespassed our Burial Ground, demolished the tin house containing various tools and belongings pertaining to the said place and tried to encroach it. We informed about this incident to the Chief Minister's office on 2nd May 2024; the copy of the said mail is enclosed herewith.

Today, on 4th of May 2024, they again have started vandalizing and breaking the old graves. Hence under such circumstances , I am praying before your good end to punish the said old lady and her associate hooligans for breaking in, trespassing, vandalizing and breaking the graves and

taking away all the belongings from the said tin room. Kindly restrain them from encroaching the burial ground in any manner, at the same time punish the culprits according to the law.
