Subject: FILING AN OFFICIAL COMPLAINT AGAINST SRI MAHESH ROY FOR HARASSMENT AND ABUSE AND I AM LODGING THIS COMPLAINT UNDER THE SCHEDULED CASTE AND SCHEDULED TRIBE (PREVENTION OF ATROCITIES) ACT, DUE TO THE FOLLOWING REASONS:

Against SRI MAHESH ROY, Son of Late Chadru Singh Roy (Das), resident of Chayanara, under Ward No.42 of Siliguri Municipal Corporation, Post Office-Salugara, Police Station-Bhaktinagar, Dist. Jalpaiguri,

Respected Sir/Madam,

I, Sri Badal Chandra Roy son of Late Chadru Singh Roy (Das), and residing at Chayanpara, Near Swagat Housing Residency, Opposite of Foresta, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, wish to officially lodge a complaint against Sri Mahesh Roy, son of Late Chadru Singh Roy (Das), resident of Chayanara, Ward No.42 of Siliguri Municipal Corporation, Post Office- Salugara, Police Station-Bhaktinagar, Dist. Jalpaiguri.

The basis of our complaint stems from Sri Mahesh Roy's persistent harassment and abuse towards our wives and us. The nature of his abuse includes the use of filthy and demeaning language aimed at defaming Me and my wife namely Minu Rani Roy, My brother Sri Prabin Chandra Roy and his wife Namely Manasi Singha Roy, both, causing humiliation by maligning our caste, and exerting criminal force in an absurd and unlawful attempt to displace us from our residence and land by using local manpower. Furthermore, he has been intimidating us through criminal force, misusing his official government position and power, thereby disrupting our peaceful possession and enjoyment of our rights.

Notably, I and my family members have become increasingly disturbed and alarmed by the malfeasance of the accused who has cunningly filed one Petition Case vide No.537/2023, dated- 13-09-2023 under Section 144 of Cr.P.C. before the S.D.E.M. Court at Jalpaiguri and one Title (Partition) Suit No.107/2023 before the Ld. Civil Judge (Senior Division) at Jalpaiguri.

I wish to draw your attention to the fact that, in response to the partition suit, the Ld. Civil Judge (Senior Division) has refused to pass an injunction order against us at this stage. The court noted that the plaintiff failed to produce credible evidence and hence, refrained from any adverse actions.

Sri Mahesh Roy has intentionally insulted and humiliated members of a Scheduled Caste (ourselves) by using demeaning caste-based language and verbally abusing us in public view at our residential place.

Sri Mahesh Roy has promoted feelings of enmity, hatred, and ill-will against members of Scheduled Castes and Scheduled Tribes by using caste-based insults and derogatory remarks.

Sri Mahesh Roy has verbally abused our wives in filthy language, making demeaning and sexually suggestive remarks, knowing that they belong to a Scheduled Caste schedule Tribe.

These actions by Sri Mahesh Roy not only violate our dignity but also constitute serious offenses under the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act.

That all such acts and conducts from the part of Mahesh Roy were duly aggravated on 5th of May at 9:00 Am.

Therefore, using this platform, we seek your intervention to prevent Sri Mahesh Roy from creating further distress and potential harm. We place our faith in your institution to bring us justice and protect our rights as free and equal citizens.

We are prepared to provide any additional evidence or testimonies as required for the investigation. Kindly consider our plea urgently, acknowledging our distressing circumstances.
