Sub – FIR against a recent incident of theft at our Under construction building site

Dear Sir,

I **SUNIL KUMAR SINGHAL** S/o **BHIM RAJ SINGHAL** resident of Vidyasagar Road, Siliguri in the District of Darjeeling bring to your attention a recent incident of theft that occurred at our Under construction building site. It has come to my knowledge that a significant amount of electric wire has been stolen from the site overnight.

The building construction site, located at [Kedarmath, Khalpara, Siliguri, Darjeeling-734005], has been undergoing development for the past few months. The stolen electric wire not only poses a threat to the progress of the construction but also raises safety concerns for the workers involved. The stolen electric wire is of significant value and might have been resold illegally. I believe that the police's involvement, along with their expertise and resources, will aid in apprehending the guilty parties and recovering the stolen property.

I kindly urge the police department to look into this matter promptly to identify the culprits responsible for this theft. Additionally, I humbly request your good self to lodge an FIR and issue me GD number for the same.
