Subject: Intimation of Theft of Underground Power Cable at Asian Highway Crossing near Galaxy Hospital

Respected Sir,

I am writing to formally report a theft incident that occurred at the Asian Highway Crossing near Galaxy Hospital, which has resulted in the loss of significant underground cable infrastructure owned by WBSEDCL.

Details of the Incident :

- **Date of Discovery :** 09.05.2024
- **Location of Theft :** Asian Highway Crossing near Galaxy Hospital, Bagdogra
- **Brief Description :** Our HT maintenance team discovered the theft during a routine check. It appears that the underground cable was extracted and removed by unknown miscreants. The theft has led to disruptions in service which impacts our customers significantly.

Technical Details :

- **Type of Cable :** XLPE 11KV 3CX300 Sqmm.
- **Approximate Length of Cable Stolen :** 140 Mtr.
- **Approximate Value :** Rs. 247573.20
- **Sub-Station Name :** Hatighisha 33/11KV
- **Feeder Name :** Atal 11KV

Hence you are requested to lodge a FIR u/s 136(1)(a) of Electricity Act 2003 and we also request your immediate intervention in this matter. The theft not only affects our operations but also disrupts essential services to the public that rely on our infrastructure. We are prepared to provide any additional information needed and assist in the investigation in any way possible.

Attached to this letter are copies photographs of the scene. We hope that these will aid in your initial assessments. We would appreciate it if you could keep us informed about the progress of your investigation and any assistance you might need from our side.
