With due regards, I, SMT, RITA SAHANI, Wife of Srishbeni Police Commissionerate Sahani, at present residing at Torijote, New Rangia, Tari, Matigara, P.S. Matigara, Dist-Darjeeling, Pin-734013, would like to lodge this written complaint to the effect that, I live in the above mentioned address along with my Husband, namely Sri. Montu Sahani S/o Lt. Bela Sahani & 2(two) Daughters and 1(one) Son. My husband, Sri. Montu Sahani S/o Lt. Bela Sahani who by profession is a truck Driver and often stays out of station and house for majority of the time, leaving me and my 3 (three) children alone at home by ourselves. But for quiet a time few of our neighbors from the above mentioned address namely, I. Sri. Surendar Sahani S/o Sri. Rambrij Sahani , 2. Smt. Lalita Sahni W/o Sri Surendar Sahani , 3. Sri. Dilip Sahani , 4. Smt. Munni Sahani W/o Sri Dilip Sahani, would get intoxicated and drunk and thereafter cause troubles to our family and other families in the locality, abusing with vulgar words, initiating fights for no good reason and other degrading acts. It is also pertinent mention here that they bully us or for no good reason have been intimidating us, especially me as my husband stays out of station for work. I have tried to talk things out with the SAMAJ(local members of the community) but all my attempts have gone to vain and futile. But in the evening of 8th of May 2024, while my Husband was out of station for work and I along with my 3(three) children went to my mother's home at Tulsinagar, Siligur and after coming from there in the late evening to my home in the above mentioned address, I came

across Sri. Surendar Sahani and Sri. Dilip Sahani drinking openly infront of my House and upon seeing me and my children they started passing foul comments and gestures about me and my Husband , they were drunk and I didn't wish to get into any kind of trouble and ignored them and came home along with my children. Subsequently, after sometime I start hearing loud noises and banging on my House Gate and when I go to enquire the same and open the door slightly / partially , Sri. Surendar Sahani and Sri. Dilip Sahani forcefully pushed the door and barged in my home. They were drunk and were abusing and asking the whereabouts of my Husband and when I try confront them, they pushed me and my children away, break furniture and fixture, utensils and manhandle me. I started to shout in plea of help, but nobody came to my rescue. Furthermore, the wives of the above named accused persons namely, Smt. Lalita Sahni & Smt. Munni Sahani also came in and upon seeing them I expected that they came for my rescue, but to my utter surprise they being a woman joined their husbands and they all physically and verbally abused me and my children and tore the cloths that I was wearing at that point and broke the furniture and fixtures, utensils and other things of my home. It is pertinent to mention here that in the midst of all this scuffle and violence they stole/ took my Bronze utensils, my money bag and snatched my gold chain from my neck. Subsequently, they have threatened me and my family with further violence and life threats if I say anything to anyone and me and my Husband should keep quiet and not raise our voice to their illegal activities, drinking, gambling and other anti-social activities in front of our house and in the locality and be numb and mute to their acts .

I ,therefore request you to kindly investigate the matter properly and take necessary legal action against the aforesaid culprits/miscreants
