Sir,

I, Shreya Panja, daughter of Sovan Kumar Panja, resident of Debipur, Shibtola, P.O.Debipur & P.S. Memari, Purba Burdwan, PIN- 713146 would like to inform you that I am a student of 3 Years LL.B at Indian Institute of Legal Studies, Dagapur, Siliguri and stay in a rented flat at Sharda Homes Block-B, Near Central Bank of India, DPS Branch, Beside Delhi Public School, Dagapur Siliguri along with two other students of the same institution named Musharat Zarrin (Mbl.No.7903744462) and Shaquia Falak (Mbl.No.8250872883), both residents of Kishanganj in the same flat.

Sir, on 09.05.2024 around 6:30 PM me along with my other two flatmates as above named had gone out for some personal work and had returned to our Flat at around 8:30 PM. Sir, when we entered our rooms, to our utter surprise, our belongings were scattered here and there and we realized that someone had committed house breaking, house breaking by night, lurking house trespass. Upon searching, I found that my black colour smart watch being model name "DIZO" and MAC Address "AA:EA:FF:CA:05:35" of "REALME" company was stolen along with Rs. 40/- (Rupees Forty only) in cash was also stolen, and the above named Musharat Zarrin also could not find her "SAMSUNG GALAXY TABLET S6 LITE" of "Oxford Grey Colour" product barcode No.(1)806094 (2)930443 and S/N:R52W90FRAXW which was also stolen. A brown colour ladies sling bag containing Rs. 3000/- (Rupees Three Thousand Only) of Shaquia Falak above named was also stolen which was kept inside her suitcase and all our other belongings were also scattered.

Sir, we all are students and stay here for our college purpose. We were very terrified of the happening of the above incidence and informed our parents in our hometown and also started enquiring the other people of the same apartment, but could not find anything. Sir, we were very terrified as we stay alone and therefore had to wait till today for filing this complaint, therefore, kindly condone our this delay.

Sir, kindly treat this matter as urgent as we live away from our family and are helpless here.

Hope your kind cooperation and immediate necessary action please in the interest of justice.
