Subject:- **REQUEST TO LODGE COMPLAINT/FIR AGAINST UNKNOWN CAR DRIVER**

Sir,

It is submitted that I, Amit Kumar Singh, Assistant Commandant (Law) posted at Frontier Headquarter BSF North Bengal, Kadamtala, Siliguri (WB) and residing at Govt. quarter in the BSF Campus, Kadamtala.

2. On 11.05.2024 at about 1330 hours after completion of my office duty, I was returning to my home on my motorcycle No. JH-18F-1736 (Honda CD-110) and passing road through BSF Gate No. 2 to BSF Gate No. 3. While passing the road, a grey colour car ran at service road in speed hit my motorcycle, due to which, I fell down in front of the BSF Gate No. 3 and roll down three to four times and got injuries/fractured in my left leg and left hand elbow (**CCTV footage enclosed**). This accident also captured in the CCTV camera but the car number could not got through CCTV footage as the CCTV camera installed in the other direction. After hitting my motorcycle who ran in speed and in rash and negligent manner, the car driver ran from the incident place without any caring to the other person.

3. After this incident, I was taken in Composite Hospital BSF, Kadamtala and treated by the doctor at that time who was on the duty. Further, I was admitted to the composite hospital in BSF campus due to fracture in my left leg.

4. In view of the above, I want to lodge a complaint/FIR against the above car driver who drove the car rashly & negligently.


