Sir on 8th May - 9th May 2024 I came to know that Jitender Yadav and his wife Indu Devi, Mobile No: 7547591, was again spreading the video and showed it to my neighbour Pallawee Singh and my her number is 9579069332 and also showed it to my younger daughter Roshni Singh (7477486870). So now sir I request you to take legal action and delete the video from Jitender Yadav's phone and all the other places where he has shared it and also request you to take strict action against him so that my daughter and my entire family can live in peace and dignity.
