I would like to inform you that from few months ago some frequent thefts has occurred in this above mentioned building namely Manosi Appartment during night period. Sometime thieves have stolen running water pipes of whole building from outside roof top, once they have stolen iron gate from the back side of the aforesaid building, once they have stolen some commercial articles from backside godown of this same building and on last night thieves have stolen one pipe inside of my backside balcony and some brass utensils which I use for Puja purpose. It is clear that this whole house is in the target of thieves.
