Crack, would like to state you that today i.e.
19/05/2024 around 4pm, when I was doing my
household works that time, I heard some noise
in front of my house, when I came out, I saw
some of my neighbour about 4/5 peoples namely
(1) Ram Sagar Roy s/o unknown to me, (2) Goutam
Roy s/o unknown to me, (3) Bhardul Roy s/o
unknown to me, (4) Kishori Roy s/o unknown to me,
Residents of motihari, Presently Address :- Dharam
Nagar, Diesel Set Crack, coolie para, Abusing
one TOTO DRIVER with filthy language
and hitting with their fist & blows. That
time, I try to stop them and said forgive
the TOTO Driver & not to abusing him.
But they got furious and started abusing
me with filthy languages. When I restrain
them to abusing me, that time they started
again abusing me with kicks and fist.
When I started making noise and started
crying the my daughter came out to
rescue me, But they are not stopping, and

Started fight with my daughter. Some of them
Disrobe my daughter & gave some bad touch.
That time my daughter call her Brother
Mr. Anwar Hussain 3/0 md. Hussain. He came
and try to stop fight. But they didn't
stop and pushing my son & some of
them punch & stop my son & hitting
