Chettri resident of Middle Palash, Devidanga, P.O. Champasau,  
P.S. Pradhannagar, Siliguri would like to inform you that  
yesterday around 4:30 - 5:00 pm when my wife Sant Ruby  
Chettri was coming from Devidanga towards middle Palash  
in her scooter bearing no. WB/74/BG/2378 one TCB (Case Copy  
bearing no. WB/73/E/7557 dashed her near Emerald Green  
Residency where she along with my daughter Akushi Chettri  
and Nanya Chettri suffered injuries and I along with local  
people rushed them to Medical North Bengal Clinic where  
yesterday at around 10:30 - 11 pm my daughter Akushi Chettri  
succumbed/expired due to her injuries and Nanya Chettri is still  
very serious and undergoing treatment. My wife Ruby Chettri  
is discharged with injuries.

Therefore Sir, kindly take strict action against such vehicle  
driver according to law for ends of justice. Thanking You
