I, Sri Vikash Lama, Son of Late Budhiman Lama, resident of Don Bosco Road, Next to Salesian College, Sevoke Road, Post Office- Sevoke Road, Police Station- Bhaktinagar, District- Jalpaiguri, PIN – 734001, West Bengal would like to apprise you that I am the proprietor of a concern namely 'NAVIK MOTORS' and my showroom is situated just adjacent to the land of 'Aayush and Aarush Engineering Consultancy'. Today morning at around 4:30 a.m. some anti-social miscreants in huge numbers illegally tried to trespass in the land just adjacent to my showroom and in doing so also made an attempt to ransack my showroom.

Be it mentioned here that the hoodlums also dismantled 2 (two) numbers of CCTV cameras which were installed outside my showroom with an illegal motive to ensure that the illegalities are not captured in the CCTV camera. The miscreants/ goons did not stop here they even brought a crane along with them and illegally manhandled and damaged some of my cars which were parked outside my showroom. My cars which are my exclusive property, were extensively damaged at odd hours and this entire episode is captured in the CCTV footage. Further these miscreants intimidate one of my guards namely Sri Bhim Biswakarma positioned outside my showroom and also snatched his mobile phone.

It is not out of place to state here that one of Dr. Manas Kumar Das, \$/o of Late Dr. Mohit Kumar Das, resident of A 19-12, Uttorayon, Post Office- Matigara, Police Station-Matigara, District-Darjeeling, PIN-734010, West Bengal had instituted a Civil Suit before the Ld. Civil Judge, (Junior Division) at Jalpaiguri and the same was registered and numbered as Title Suit No. 234 of 2024 wherein I was impleaded as one of the defendants. On 08.04.2024, the Ld. Court was pleased to pass an order directing both the parties not to make any change to the suit land.

I have strong apprehension that these illegal miscreants are working at the behest of Dr. Manas Kumar Das and some land mafias who have a malafide motive to cause serious damage to my property and life. They have no respect for the law of the country and are trying to intimidate me by taking law into their own hands. It seems that this entire episode was orchestrated and strategized at early morning so that I may not be able to do anything and they could violate the solemn order of the Ld. Civil Court. It is pertinent to state here that due to the destruction of 2 (two) numbers of CCTV cameras, I have sustained a loss of a Rs.10,000/- (approx.). Furthermore the damage caused to the cars parked outside my showroom is yet to be assessed.

Under the aforesaid premise, I humbly request you take stock of the entire incident and unearth the truth and conduct a thorough investigation so that criminal law is set in motion. I am ready and willing to render all necessary cooperation to your good office.
