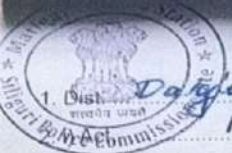

Respected Sir,

With due respect, I am Pappi Ray S/o. Umesh Ray, Resident of Tumba jote, Beldangi P.O & P.S -Matigara, Dist- Darjeeling, Pin- 734010, would like to draw your kind attention about following Facts-

That today around 02:30 P.M when I and Jiten Prasad, S/o Munib Prasad with our few friends went to our joint property which is situated in Tobma jote, Beldangi, near Sani Mandir more, P.S & P.O- Matigara, Dist-Darjeeling, Pin-734010, as soon as I unlock the key of the gate one 1) Md. Amzad Ali S/o Mehboob Ali with his family members 2) Sajad Ali, S/o Md. Akram 3) Sogo Khan, S/o Md. Amzad Ali 4) Altaf Ali, S/o Amzad Ali 5) Noorbanu Begum, W/o Amzad Ali 6) Madhuri Prasad, W/o Amzad Ali and 7) Niranjana Mandal, S/o Not known all are the residing at Tumba jote, Beldangi P.O & P.S -Matigara, Dist- Darjeeling, Pin- 734010 along with more or less 6 other persons who is known to be Land mafia of that area, said Amzad Ali came there and attacked one lady Sovia Hela with iron Rod and we try to save her they started attacked on us with Sharp weapon and with Talwar, Jiten Prasad and Ajay Sing were got injured seriously. They attacked on Jiten Prasad with iron rod on his head. They also broke our two Bike and my new Scooty with No. WB 74 BS 3485, WB 74 BM 5503 and they took 2 Scooty being registration Number WB 74 ~~AS DS~~ 3445 and all my Documents, credit Card and cash Rs. 35,000/- (Thirty Five Thousand) only. During the fighting they also snatch my Gold chain approx 15 gram and Jiten Prasad's Gold Chain which is 16 gram. They all have sharp weapon, talwar and iron rod with them, to save our life we ran away from there.

But after sometime around 3:09 P.M All of them the above name persons came to my house and started abusinf us with filthy languaages and asked us to come out furiously my wife and my mother came out of the room and they started assaulting my mother watching this my wife namely Chumki Dhar came between them trying to rescue my mother then the mob leded by said Amzad Ali left my mother and started assaulting my wife in the course of such physical abuse they pulled my mother by hair but she tried to fight back and on that movement they hit my mother.

At that point of time my wife requested the mob and said Amzad Ali to leave them but said Amzad ali insted of listening to her pulled her out of the room and started molesting her by graving

her breasts many of them touch her inappropriately some of them tried to rape her at that time few of them were capturing me and I was helpless.

We started shouting loudly when my neighbour listen our sound they all came to save us. When they attacked in my house its recorded in the CC TV camera. They giving us life threat to us that they will kill all of us. We are very much afraid right now and our life is in danger.

We are still in afraid, they continuously threatened us and sending random person outside our home. We cannot even go to our home as our life is in danger.

I am helpless and have nobody to seek help from. And with no resourse left with me. Therefore, it is my humble request kindly help me and save me and my family from them. And take necessary step for the end of justice.
