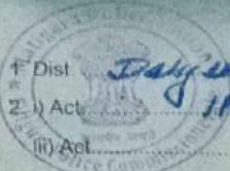

Dear Sir,

With due respect I **Sri Sujan Sarkar**, S/o. Sri Sudhir Kumar Sarkar, resident of Ramkrishna Sarani, P.O. Kadamtala, Dt. Darjeeling would like to inform you that I am the bonafide tenant of a shop room measuring about 96 sqft situated at Indrapally, P.S. Matigara, Dt. Darjeeling (south side of Shibmandir bazaar) which was let out by one Sri Haren Singh at and for the price of Rs 525/- Per month as rent at the time of execution of agreement for rent he took a sum of Rs. 2,00,000/- (two lac) from me as security deposit (non refundable). I am paying the monthly rent in monthly basis regularly till April 2024. Meantime the aforesaid landlord and his wife is creating disturbance to disposes me from my tenanted shop. They are creating different type threat coercion with the help of their hired hooligan companion for the purpose of disposes me. Today at about 10.00 AM the aforesaid Sri Haren Singh and his Anjali Singh and Bisakhi Shill with the help of their companion broken the lock of my shop and enter in to my shop room. When I informed the above said incident instantly appeared there that time they became very violent and started using filthy languages to me when I protested strong that time they beaten me mercilessly and I sustained bodily pain. From the interference of local people they leaved the place. After their leaving I entered in to my shop room then I saw my mobile accessories and furnished item of Rs. 50,000/- (Rupees fifty thousand) is missing which was kept inside my shop room in last night.

In this above circumstances I am running my days with full of danger and misery that is why I am requesting you to please nab the accused persons immediately from my kind perusal.
