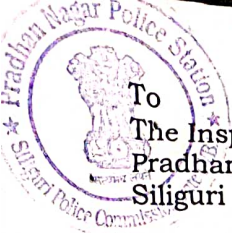

Sir,

In producing herewith 02 (two) accused persons namely (i) Sk. Munna (M-33 yrs) S/o Sk. Nur Aalam of vill- Gutiyarisor, P.O. Gutiyari, P.S. Taldi, Dist. South 24 PGS, Kolkata and (ii) Md. Ashik (M-32 yrs) S/o Md. Sharif of vill. Turkuliya, P.O. Kamalpura, P.S. Paru, Dist. Mujaffarpur, Bihar under arrest along with following articles under seizure viz :- (i) 01 (one) paper made cartoon containing 12 (twelve) bottles of Old Monk Deluxe Rum containing 750 ml in each bottle i.e. total (750 ml x 12)= 09 litres and marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1", from the possession of Sk. Munna (M-33 yrs) S/o Sk. Nur Aalam of vill- Gutiyarisor, P.O. Gutiyari, P.S. Taldi, Dist. South 24 PGS, Kolkata and (ii) 01 (one) paper made cartoon containing 12 (twelve) bottles of Old Monk Deluxe Rum containing 750 ml in each bottle i.e. total (750 ml x 12)= 09 litres and marked as Exhibit "B" out of which one bottle of the same taken as sample for examination and marked as Exhibit "B1", from the possession of Md. Ashik (M-32 yrs) S/o Md. Sharif of vill. Turkuliya, P.O. Kamalpura, P.S. Paru, Dist. Mujaffarpur, Bihar. I, ASI Biplab Kr. Das of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused persons namely i) Sk. Munna (M-33 yrs) S/o Sk. Nur Aalam of vill- Gutiyarisor, P.O. Gutiyari, P.S. Taldi, Dist. South 24 PGS, Kolkata and (ii) Md. Ashik (M-32 yrs) S/o Md. Sharif of vill. Turkuliya, P.O. Kamalpura, P.S. Paru, Dist. Mujaffarpur, Bihar to the effect that on 21.05.2024 at 23.15 hrs I received a source information that two persons standing at Siliguri Junction Bus Stand with illegal liquor and waiting for a Bihar Bound Bus. Accordingly, I diarized the fact in General diary vide Pradhan Nagar PS GDE No 1207 dated 21.05.24 and share the information with you.

As per your kind order and direction, myself along with officers and force left for Siliguri Junction to work out the information in hand. After arrival at Siliguri Junction and as indicated by the source I noticed that two persons are standing at Bus Stand with two paper made cartoon in their possession. Accordingly, I detained them at Siliguri Junction Bus Stand. On interrogation they disclosed their identity as noted above. On further interrogation they disclosed that they illegally possessed illegal liquor from Siliguri and waiting there for a Bihar bound bus with a view to sale the same in Bihar in higher price for their illegal gain. On search the paper made cartoon from the possession of accused Sk. Munna recovered 12 (twelve) bottles of Old Monk Deluxe Rum containing 750 ml in each bottle i.e. total (750 ml x 12)= 09 litre and the paper made cartoon from the possession of accused Md. Ashik recovered 12 (twelve) bottles of Old Monk Deluxe Rum containing 750 ml in each bottle i.e. total (750 ml x 12)= 09 litre. On demand they failed to produce any valid documents in respect of above noted illicit liquor recovered from their possession. Accordingly, I seized the same under proper seizure list from their possession and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest at the spot for violating the norms of Bengal Excise Act and inform him about the ground of their arrest. The search and seizure made in between 00.15 hrs to 01.05 on 22.05.24. During further enquiry it could be revealed the above noted two accused persons are involved such type of illegal business since long for their wrongful gain.

Therefore, I pray before your good self that a specific case may kindly be initiated against accused namely (i) Sk. Munna (M-33 yrs) S/o Sk. Nur Aalam of vill- Gutiyarisor, P.O. Gutiyari, P.S. Taldi, Dist. South 24 PGS, Kolkata and (ii) Md. Ashik (M-32 yrs) S/o Md. Sharif of vill. Turkuliya, P.O. Kamalpura, P.S. Paru, Dist. Mujaffarpur, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
