In producing here with one arrested accused person namely Gafar Ali (40) S/o Nurul Haque of Kathambari PS Malbazar Dist. Jalpaiguri and seized 01 (one) vehicle Dumper having registration No. WB-71-B-9512 loaded with river bed materials as per proper seizure list.

In this regards I SI Kazi Rejaul Karim of New Jalpaiguri PS , SPC lodged a written complaint against the above noted arrested accused person to the effect that on the night of 17/18-05-24 myself alongwith force C/1473 Goutam Roy ,C/1035 Sontosh Rabi Das and CV-300 Madhab Roy were performed Night Mobile duty vide NJP PS GDE No. 838 dt. 17.05.24. On 18.05.24 at 00-05 hrs I received source information that some loaded vehicles were seen with carrying riverbed material illegally through Canel road and moving towards Fulbari side. Accordingly I informed the matter to the O.C. NJP PS and also duty officer of PS which is diarised vide NJP PS GDE No. 848 dt. 18.05.24 . As per direction myself alongwith force reached at Canel road near Babamoni weighbridge and found that the above noted vehicle (Dumper) loaded with riverbed materials was coming from Ambari side. I alongwith force detained the said vehicle at Canel road near Babamoni weight bridge under PS NJP and apprehended the driver of the said vehicle, on asked he disclosed his name and address mentioned above and found that the said vehicle was loaded with riverbed materials. On demand the driver of said vehicle failed to produce any documents/papers in favour of the carried substances (riverbed materials) and also failed to produce papers in support of the said vehicle. During enquiry it could be ascertained that the riverbed materials were loaded from Chel river illegally. Thus it is suspected that the organized racket in operation for carrying riverbed materials illegally for wrongful gain and thereby causing huge revenue loss to the Government of W.B. As such I seized the above noted vehicle loaded with riverbed materials with proper seizure list and arrested the driver of the said vehicle u/s 41 Cr.P.C after maintaining all formalities of law. The seizure and arrest was done in between 00-55 hrs to 01-25 hrs.

Under the above circumstances I pray that a specific case may kind be started against the arrested person namely Gafar Ali (40) S/o Nurul Haque of Kathambari PS Malbazar Dist. Jalpaiguri and arrange for its investigation .
