Subject: FIR against the incident of snatching of gold chain by unidentified criminal.

Dear Sir,

With outmost anxiety and concern, I would like to draw your attention to the fact that I have become a victim of an incident of snatching of gold chain by unidentified criminal yesterday evening right before my own residence at about 7:50 p.m in the evening.

To report the incident, Sir, I undertake to state that, I am a resident of undermentioned address and generally we some elderly women of the neighbourhood gather in front of our houses for casual interactions every evening. Yesterday at the hour mentioned above when we were engaged in exchanges a motorbike halted by us seeking help to find a location nearby. The person had put a helmet on the head that we could not see his face clearly. He took out a piece of paper containing a handwritten address o which I could only explain the location of Lake Town Kalibari according to his query. As soon I went closer to him on his insistence to see the piece of paper he had, the man suddenly ended the discussion and drove away as he kept the engine of the bike running all through. No sooner he left, I felt the gold chain around my neck is gone. The man snatched it so sharply that I could hardly had the reflex to feel the snatching. I tried to observe the numberplate of the motorbike, but he left I such a hurry, that I failed to understand whether the bike at all had any numberplate. Other neighbours came out from their houses listening to our shouting, some even forwarded to the way the criminal had gone, but all were in vain. It was a 7 gm. gold chain that I lost in this frightful occurrence.

I, therefore, while reporting the incident request you to treat this complaint as F.I.R and initiate necessary legal and investigative action to probe into and ensure me justice from your end.
