I Md. Akram Quraishi, So. Lak Mouddin Quraishi, resident of Quraishi Mahalla, Near, Dr. Rajendra Prasad School, Ward no. 6 of S.M.C. P.O & P.S. Siliguri, Dist Dujelding to here by lodge this P.I.R against some anti social persons to the effect as follows: -

That on dated 23/05/2024 around 9 PM, my son namely Ashraf Quraishi, aged about 17 years went "Baisheki mela" near Talpansare in Ward no. 5, Burdwan Road, Siliguri, with my other family members.

In the time of enjoying in mela, that a person name not known taking my daughter & started Eulaching, like throwing peanuts on her head & giving bad comments. My son Ashraf noticed him & warn him to do not doing all the bad things, but he did not stop & told him, that he is a Police Cop & showing a Id Card & keep the Card in his pocket & started threaten him, he started beat him with a stick suddenly some persons's namely -

the incident place & started beating my son  
with Iron Rod & Bamboo stick, they loote my  
son cloth, & started to mude him.

They misbehaine my daughter also & my other  
family members. They beater my son in badly  
Condition, his get serious injury on head,  
nose, lip, chest & back. With cause of  
Iron punch he get injury in his face. Blood  
were swelling by his nose & lip. They try  
to kill him & my another family members.

Entire incident has been recorded in  
C.C.T.V footage which is install in metal  
ground. The local people call the police &  
they save my son's life.

All the persons are local resident of the  
ward no-4 & 5. After the incident I know  
they are local goons of that area & taking  
money like illegal parking & other tax.

Now my son is very serious & admitted  
in King's Hospital situated at Anoke  
more. Doctor refer him to the I.C.U


