I, Anusha Das, resident of Anusbinda
Pally, Siliguri would like to file a
complaint against my husband Sudip
Kumar Das for the physical assault
towards my daughter, father and
uncle.

On 25/5/2024, at night 10:30pm,
as my daughter was unavailable to go
to tuition he hit her with a plastic
rod on head which led to severe
bleeding and injury. As such I was
scared of the situation, went outside
of my flat for help and called my
mother to send my father and uncle to
my flat immediately at Anusbindapally.

1 When my father and uncle arrived at our flat, and was asking about the situation to my husband, he pushed both of them from the staircase of first floor to ground floor. Then he came to hit with another hammer for further hitting. He could not proceed it due the other flat members came for help. I shouted and screamed for help. Due to sudden trauma and hitting, my father and uncle was fiercely bleeding and injured badly. We immediately took them to Siliguri district hospital for ~~an~~ immediate medical facility. Please find the attached document of District hospital.

As such Sir, I request you to kindly take immediate measures for our safety.
