I, Smt. Pampi Mitra, W/o. Sri Paritosh Mitra, residing at Tumul Para, Ward No.04, P.S.Siliguri, Dist.Darjeeling would like to inform you that my husband namely Sri Paritosh Mitra, S/o. Late Nityagopal Mitra runs a grossary shop at the above noted address and just in front of our grossary shop we have an another plot of land and yesterday i.e. 25.05.24 at about 04.30 p.m. when me and my husband present at our shop at that time my neghibours namely **Smt. Asha Banik, W/o. Moni Banik, Smt. Soma Banik W/o. Sri Subir Mallick, Sri Subir Mallick, S/o. Late Sunil Mallick, and Smt. Niha Mallick D/o. Sri Subir Mallick**, all of them are resident of above noted address without any reasons they tried to grab our land which is situated just in front of my grossary shop and after seeing the same when me and my husband tried to protested the same at that time the above noted persons without any reasons used slang languages in respect of me and my husband and when me and husband tried to protested the same at that time the above noted persons with an intention to kill me and my husband they started to assaulted us with the help of **Rod, Bamboo** and by the aforesaid way they intentionally tried to kill me and my husband and due aforesaid reasons me and my husband sustained multiple injuries on our whole body and at the time of the aforesaid incident the above noted persons forcefully dragged me at their house and after that they intentionally disrobe me by the way of torned my wearing apparels and specially the above noted male person touched my body parts and by the afopresaid way all of them disrobe me intentionally and it is also important to mention here that at the time of the aforesaid incident the above noted persons intentionally took away one gold chain from my neck and they also broken my bangel and at that time after listening our hue and cry some local people came to the sopt and rescued us and during the aforesaid period they also threatened us with dire consequences and told us that if me and my husband informed the aforesaid incident to any authority then they will kill us so, no other alternative way I lodged this complaint before you.
