Sir,

I, SMT. SABITRI NIROULA, Daughter of Sri Basudeb Niroula & wife of Sri Binod Poudel, residing at, upper Bhanunagar, Post Office – Sevoke Road, Police Station – Bhaktinagar, Pin – 734001, District – Jalpaiguri, would like to inform you that I am the owner of a plot land measuring about 3 Katha 6 chhatak in R. S. Plot No. 749, L. R. Plot No. 596, recorded in R. S. Khatian No. 253/2, within Mouza – Dumriguri, J. L. No. 94, Pargana – Patharghata, Police Station – Bagdogra, District – Darjeeling, by virtue of a Deed of Sale being No. 7597 of 2009. Subsequently, the said land was recorded in my name in L. R. Khatian No. 1218, vide L. R. Plot No. 596.

Sir, recently I got information from reliable sources that one SRI MANOJ SHARMA fathers name not known and his wife namely PATRICIA BHUTIA SHARMA, of Gosaipur, Mamata Nagar near Loknath Mandir, P.O. & P.S.- Bagdogra are trying to grab my aforesaid land from the southern side. At this, yesterday, when I visited my land I saw that the above named persons, who are staying and/ or residing adjacent to my said land, have illegally constructed a portion of their house by encroaching a portion of my land from the southern side. I have raised objections and requested those persons not to encroach upon my land but, hearing my objections they became furious and threatened me.

It is to be mentioned here that one GERAT TAMANG, fathers name not known, having Cell Phone No. 98320-74914 over telephone threatened me several times and told me that I will face dire consequences if I decide to proceed with the protection of my land. Moreover, on 22/05/2024 one PATRICIA BHUTIA SHARMA also threatened me over cell phone having no.9564492459 by saying that they shall encroach upon my land and no matter whatever I do, nothing is going to deter them. Be it mentioned here that they and their associates tried to enter into my aforesaid land by breaking lock of the gate but due to my active interference they could not succeed.

Sir, the above named SRI MANOJ SHARMA, and his wife PATRICIA BHUTIA SHARMA together with one GERAT TAMANG and their associates may enter into my land by breaking the lock of the gate and take physical possession of my entire land at any moment illegally and unlawfully by taking law in their own hands.

Your good office is therefore requested to look into the matter and do the needful and also take appropriate action against the above named persons together with their associates those who are trying to enter into my land and also trying to occupy the same for their illegal and unlawful gain and save me and my property from such illegal & unlawful activities.
