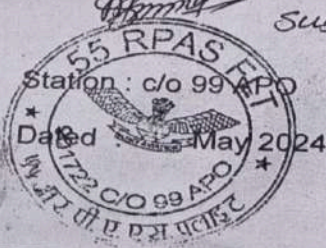
FIRST INFORMATION REPORT

1. It is intimated that JC-285535M Sub Sujit Kumar, presently serving in 55 RPA Flt/659 Army Avn Sqn (R&O), Shiv Mandir, Siliguri. The indl is residing at Qtr No- T/J/746/01 'U' Area, Shiv Mandir. On 23 May 2024 at approx 1920 hrs when the indl was returning to his home on motorcycle after attending the unit parade (roll call), met with an accident while crossing traffic signal in front of NBU gate No 2. The indl got hit by Truck 2.5 Ton of 463 PET PI ASC, Bengdubi. The Truck 2.5 Ton was heading towards Bengdubi and Sub Sujit Kumar was crossing the traffic signal towards NBU Gate No 2. The Truck 2.5 Ton hit Sub Sujit Kumar from the front side, due to the impact of accident Sub Sujit Kumar's helmet took off from his head and he got badly injured. The Truck 2.5 Ton which was coming from Siliguri side did not stop on red light of traffic signal. The traffic police at NBU Gate No 2 immediately took the injured JCO in autorickshaw to North Bengal Hospital (Medical College). Once the info of accident came to notice to Sub Pandappa M of 55 RPA Flt, he immediately sent Sub Mahesh Kumar to North Bengal Hospital (Medical College). The JCO found Sub Sujit Kumar in a critical condition so he took him immediately to 158 Military Base Hospital, Bengdubi on advice of doctor on duty at Hospital. The indl due to his critical condition was placed on Dangerously ILL List (DIL) by the 158 Military Base Hospital and a medical legal case is opened by Base Hospital. The indl immediately underwent several medical diagnosis and was admitted to ICU. On very next day (24 May 2024) due to his critical condition, the indl was referred to Command Hospital (Eastern Command), Kolkata for further necessary treatment. The indl presently in ICU at Command Hospital (Eastern Command), Kolkata.
