With humble request I sut Sushruta Bhounick w/o Sudip Kr. Bhounick, house no 313, near Gohosh Medical Stores, Vill-Thikrikata, PO-Sushruta Nagar, Medical would like to inform you that on 21/5/24 when I reached my home around 10 pm, I saw that my main entrance was locked as it was earlier but the inside entrance lock was broken along with my 1<sup>st</sup> floor roof lock. I saw after entering that all the things of bed, furniture, Crochets etc were scattered and the thieves have broken and stolen all the tops of my wash-room and kitchen. They have entered my house through roof by climbing a Tree which planted at my house garden. Earlier also from 2012 it is 3 times already theft done in our house. I live along with my minor son only and these kind of incidents effects our safety and we feel that we are in danger. So, I would request you to investigate the matter on priority. It is also mentioned that there is no material connection in my house after theft.
