With due respect and humble submission,
I Biswas Mukhia, S/O Lt. Asir Bahadur Mukhia, permanent
resident of Nagari farm, P.O. Nagari spot, P.S. Sukhia
Pokhri, Darjeeling, Dist - Darjeeling beg to state that me
and my family member including my girlfriend in the
presence of my family some local people naming Ajit
Saha, his mother and some friends of Jyoti Nagar, Siliguri
has beaten us very harshly and brutally resulting to
injuries of forearms, neck and head. Hence, the doctor
has advised for immediate admission to hospital as the
injury is very severe. Our clothes have also been torned
and Miss Karuna Thami (our family member) resident of
Pankhabari, Ramhatti, Kurseong has also been hit on her chest
areas and too her hair was pulled and very abusive
words were used in open public hitting and beating us
both without any reason. Even after acting as a decent
society member we get to face such type of harrasment
which results in mental torture and physical abuse.

Therefore, we request you to take necessary
action against the culprit and give me and my friend
some mutual relief.
