Subject: - F.I.R.

Sir,

In producing herewith one arrested accused person namely Bittu Kumar (26), S/O Surendra Kumar of Sahapurpatty, PO. Nekhnampur, PS. Sahebganj, Dist. Muzaffarpur, Bihar under arrest along with following articles under proper seizure:-

(i) 12 (Tweleve bottles) bottles of 12 Old Monk Delux Rum Mgf Date 26.02.24, batch no 244, M.R.P. Rs. 254/- per bottle, total (12 x 750 ml) = 9000 ml and marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A-1".

I, SI Bandhan Roy of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested person that on 29.05.2024 at 22.15 hrs I received a specific source information that one person carrying huge quantity of illicit liquor without any valid license is standing at Siliguri Junction, Raj Bus Stand and waiting for a Bihar bound Bus without any valid licence. Accordingly, I share the information with you and noted in GD book vide Pradhan Nagar PS GDE No. 1574 dated 29.05.2024.

As per your kind order and direction, I along with force left from PS to held raid at Siliguri Junction, Raj Bus Stand under Pradhan Nagar PS and as per identified by source managed apprehended one person. On being asked he disclosed his identity as noted above and on search him, I recovered above noted articles kept in a paper made cartoon. On demand he failed to produce any valid license/papers for poeesing and carring travelling of such illegal liquor. On further interrogation he stated that he is involved in this business that he travelling and selling of liquor without any valid license since long for his illegal gain to his design customers at Bihar. Accordingly, I seized and label the above mentioned illicit liquor from his procession in between 23.00 hrs to 23.40 and subsequently, arrested the above mentioned detained person namely Bittu Kumar (26), S/O Surendra Kumar of Sahapurpatty, PO. Nekhnampur, PS. Sahebganj, Dist. Muzaffarpur, Bihar after observing all sorts of formalities at the spot for violating the norms of Bengal Excise Act and inform him about the ground of his arrest.




