With due respect, In producing herewith one accused person namely Najimuddin (40 Miguri Chhotey Ali of Maniharan Bhojpur, Pipalsana Ahatmali, PS Bhojpur Dist. Muradahad Maniharan Bhojpur, Pipalsana Ahatmali, PS Bhojpur Dist. Muradabad , State Uttar Pradesh under arrest alongwith seized cattles and seized vehicle;

- (i) Total 26 (Twenty Six) nos of Cattles in different size and white color.
- (ii) One vehicle having registration No- HR-67-D-6954 which was used to carry the seized Cattles SL. No. 1.
- (iii) One driving License having No. UP2120090022893 in the name of Nizamuddin s/o Chhotey Ali of Moh Maniharan PS Bhojpur, Moradabad, UP, valid upto 24.02.29 Issued by Moradabad, Uttar Pradesh.

I ,SI Rana Bramha Of New Jalpaiguri PS under Siliguri Police Commissionerate do here by lodged a written complaint to the effect that on 27.05.24 myself alongwith force were performing morning mobile duty vide NJP PS GDE No. 1956 dt. 27.05.24 and at 08-10 hrs I received a secret source information that some vehicles are being loaded Cattles illegally and coming from Ghoshpukur side towards Jalpaiguri sidethrough bypass roadwithout any valid documents/papers and if immediate action is taken, it can be apprehend. Accordingly, I share the information with O/C New Jalpaiguri P.S and duty officer of PS and diarised the matter vide NJP PS GDE No. 1961 dt. 27.05.24 and as per his direction myself along with C/1035 Sontosh Rabi Das, VP-08 Lakhan Roy, NVF-0064 Parimal Roy left for Amaidhighi More under NJP PS to verify the veracity of information. At about 08-25 hrs we reached at Amaidhighi More and started upcoming vehicle checking on that road and on the basis of secret information at 08-35 hrs we intercepted the above vehicle having registration No- HR-67-D-6954 and apprehended the driver of the said vehicle. On checking the vehicle we found total Total 26 (twenty six) nos of Cattles in different size and white color were loaded on the vehicle. On being asked the apprehended person disclosed his name and address mentioned above which is not verified and admitted himself as driver of the said vehicle and he was carrying the cattles from Bihar side towards Jalpaiguri for sale illegally to his designation customers. On asked, he failed to produce any valid License/ papers in support of carrying the said Cattles in the vehicle and also failed to produce any papers in respect of the said Cattles. It is crystal clear and reason to believe that the above noted accused person procured the said cattle by illegal means or by stolen means for dishonestly dispose the same for his illegal gain. On further checking it was found that there was no arrangement made for food and water for the said Cattles as per Govt. rules. Besides this there was no sufficient space for the Cattles in that vehicle. The apprehended driver of the vehicle also failed to produce any papers/documents in support of the said vehicle. Accordingly I seized Total 26 (twenty six) of Cattles in different size and white color and (ii) One vehicle having registration No- HR-67-D-6954 which was used to carry the seized Cattles as per proper seizure list duly sign by the witnesses. As such I arrested the above noted accused person after observing all formalities. The seized 26 (twenty six) nos cattles handed over to the Fulbari Khowar for safe custody. The accused person is violated The Prevention of Cruelty to Animals Act 1960. The seizure was made in between 08-35 hours to 09-25 hours.

Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the above noted accused driver of vehicle No. HR-67-D-6954 `namely Najimuddin (40) S/O-Chhotey Ali of Maniharan Bhojpur, Pipalsana Ahatmali, PS Bhojpur Dist. Muradabad , State Uttar Pradesh to arrange for its investigation.
