Sir

I, Sri Aktar Sardar, S/O Late Abdul Jabbar Sardar resident of Tulat, PO-Bholanathpur, PS-Kumarganj, Dist.-Dakshin Dinajpur, 733141 posted as Station Manager at Fulbarihat C.C.C under P.S NJP, District: Jalpaiguri, empowered by the Electricity Act 2003 (Amendment Act 2007), hereby lodge this complaint against (i) Naisad Ali and (ii) Karun Md, both resident of Joydev vita under NJP PS, Dist- Jalpaiguri for the violation of U/S 135/1/E & 150 of the Electricity Act 2003 respectively as stated below.

On the afternoon of 27.05.2024, I, accompanied by my staff, including Mr. Srikanta Chakraborty, S/O Mr. Nihar Chakraborty, J.E (E) Grade-II, and Mr. Suranjit Sarkar, S/O Late Paran Chandra Sarkar, ACM attached to Fulbarihat C.C.C, WBSEDCL, along with S&LP unit Jalpaiguri Regional Office headed by Swapan Saha, D.E. conducted a raid and inspection at the premises of Naisad Ali & Karun Md at Joydev vita.

During the inspection, it was discovered that, Naisad Ali (401318867) is supplying electricity connection unauthorized to a disconnected premise of Karun Md (422137722) who is a defaulter of WBSEDCL having unpaid OSD of Rs.49097/- as on 27.05.2024. Hence, Naisad Ali is accused of violating U/S 135/1/E and Karun Md is accused of violating U/S 150 of the Electricity Act 2003, in accordance with the Amendment Act 2007. I have prepared an inspection memo from 4:20 PM to 4:35 PM and disconnected electricity connections of both the consumers and both Naisad Ali & Karun Md has signed in the inspection report. Seizure list and Zimmanama of both the accused has been annexed for reference.

I kindly request that you take the necessary action in this matter.
