Respected Sir,

I Sri Anuj Kumar Singh, Son of Sri Bhagwat Singh, resident of behind old Anchal Office, Champasari, Police Station Pradhan Nagar, District Darjeeling do hereby lodge this written F.I.R to the effect stating that today on 31.05.2024 at about 3.45 AM, my truck driver named **Ram Chandra Ram**, Son of Sukrut Ram, residing at Ujanu Shiv Nagar, Police Station Pradhan Nagar, District Darjeeling was on morning walk going from Darjeeling More towards Champasari and he was walking on left side of road and having reached near FREE KICK VENTURE PETROL PUMP(Commonly Known as Bhaichung Bhutias pump) at that time one vehicle bearing Registration No WB74BB7760 driven by the driver in drunk condition and driving in zig zag manner and in rash and negligent manner hit my driver from back causing death and the driver fled away from the spot and ran away.

I was informed by the local people about the accident and when I reached the spot I saw my driver lying down without any body movement and then I took him to Siliguri Civil Hospital by ambulance and the doctor on duty told that he is brought dead.

So I request you to kindly register this F.I.R and take legal action against the driver of the vehicle bearing registration No WB74BB7760. The vehicle number was given to me by the local people.
