I, Dr Rabindra Nath Chakraborty (84 yrs) S/O Late Hrishikesh Chakraborty resident of Meghnath Saha Sarani, Ward No-02, PS- Pradhan Nagar, Dist.- Darjeeling beg to inform you that, I have a three stored building at the above noted address in which in the 2 nd floor my son namely Dr Koushik Chakraborty is residing with his family. On 25.05.24 my son with his family left the house for a tour and his flat was key and locked. On 01.06.24 at around 09.00 PM I found the lock of the main door of the flat of my son is broken. Later we came to know that unknown miscreants entered into the flat of my son by breaing the lock of main door and stolen cash Rss 50,000/- (fifty thousand) and a gold bangle worth Rs 80.000/- (eighty theousand) from the flat.

However, kindly go through the matter and take remedial measures to get back the theft amount as early as possible.
