**(Sub:-Complaint against land grabbers.)**

Respected Sir,

With due respect I, SRI. ANURAG JAISWAL, Son of Sri. Arun Jaiswal, resident of Aashiana House, Shes Basanta Road, Jyotinagar, Ward No. 41 of SMC, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, West Bengal-734001 beg to state that I am absolute owner of a piece of land measuring about 9.05 Kathas or 0.1494 Acres, situated under R.S. Plot No. 18, corresponding to L.R. Plot No. 361, recorded in R.S. Khatian No. 840/11 and 840/17, L.R. Khatian No. 3024, within Mouza Dabgram, Located Near Manokamana Flour Mills, Eastern By Pass, J.L. No. 02, R.S. & L.R. Sheet No. 04, P.S. Bhaktinagar, Dist. Jalpaiguri, having all valid documents of title and ownership.

Since the month of October, 2023 some persons of the said locality namely Sri. Krishna Roy, S/o. Late Shyamlal Roy, Sri. Sudhir Roy, S/o. Late Shyamlal Roy, Sri Bipesh Roy, S/o. Late Shambhu Roy and others have been obstructing me by different means in the peaceful enjoyment of my land and they are demanding huge money from me. Finding no other alternative, I have filed a civil suit against said Krishna Roy and others in the Court of Ld. Civil Judge Junior Division 1st Court at Jalpaiguri being Title Suit no. 690/2023 and Ld. Court has passed an order and thereby restrained the defendants i.e. said Krishna Roy, Sudhir Roy, Bipesh Roy, Md. Aftab and their men and persons from causing any interference in my peaceful possession and forbidden them from creating any annoyance or mischief over my above mentioned land, and the said order is still enforceable.

Inspite of above mentioned order of the Ld. Court, the above named Krishna Roy, Sudhir Roy, Bipesh Roy, Md. Aftab and their men and persons namely Smt. Mina Roy, Smt. Renuka Roy, Smt. Manuka Roy, have been continuously disturbing me in my

peaceful possession in my land and they are disregarding the order of Court. Moreover on 01/12/2023, when I was doing some repairing works over my said land, the above named persons have come to my land with deadly weapon and started to abuse me and they have assaulted my labours and staffs, they have also tried to capture my land illegally by violating the courts order. **T Today 02<sup>nd</sup> june when I came to the land they have destroyed my tin shed boundary and have stolen all the ms pipe and tin which was put there. I have a injunction order and a restraining order till 10/7/2024.**


Sir, I could not enjoy my property due to the continuous disturbance of above miscreants over my property.
