I LASI Kalpana Chhetri presently posted as Siliguri PS, SPC do hereby lodge this complaint against 1] Sanjit Gupta, Leader of Bharatiya Janata Party (BJP), 2] Madhumita Saha of Ghogomali, W/N- 37, PS- Bhaktinagar, Dist- Jalpaiguri, Leader of Bharatiya Mahila Morcha, 3] Mahua Bose Tarafdar of Deshbandhupara, w/n- 29, SMC, PS- Siliguri, Dist- Darjeeling and other approx 25 supporters of Bharatiya Mahila Morcha to the effect that today on 01.06.2024 approx 55-65 Mahila supporters of Bharatiya Mahila Morcha of Darjeeling District Committee were gathered at Baghajatın Park, under Siliguri PS jurisdiction and at around 14.15 hrs they arrived at Siliguri Municipal Corporation gate and tried to enter to the premises to show demonstration against the SMC authority over the issue of Drinking Water Problem in the Siliguri Municipal Corporation area. They were carrying banner & flags of Bharatiya Janata Party (BJP).

Already many officer and force consists some Lady Officer and force were deployed in front of SMC to maintain Law and order situation.

Subsequently deputed police officers and force available there politely prevent them to maintain law and order situation. Suddenly some of the supporters of BJP, Mahila Morcha got more furious and break the Police cordon. Finding no other alternative we started to push them off and at the same time we directed them to maintain peace and free flow of traffic in the busy road in front of SMC. On reinforcement I along with LASI Urshila Lalbegi, Lady Constable Swastika Sharma, Riya Sarkar, Pushpanjali Yonzon, Anisha Biswakarma got severe injury and treated at North Bengal Medical College & Hospital. Some other police personnel also got injury from the agitation.

On reinforcement other supporters of BJP started to leave the place carelessly and aimlessly by throwing and breaking clay pot in the road.

Now I request you to start a specific case under proper section of law and take proper legal action against the above noted accused persons namely 1] Sanjit Gupta, Leader of Bharatiya Janata Party (BIP), 2] Madhumita Saha of Ghogomali, W/N- 37, PS- Bhaktinagar, Dist- Jalpaiguri, Leader of Bharatiya Mahila Morcha, 3] Mahua Bose Tarafdar of Deshbandhupara, w/n- 29, SMC, PS- Siliguri, Dist- Darjeeling and other approx 25 supporters of Bharatiya Mahila Morcha for detering Police personnel to perform their lawful duties and blocking the free flow of traffic on public road.
