In producing herewith Five arrested accused persons namely 1] Mithilesh Kr. Sah (30 yrs/M), S/O- Raj Narayan Sah of Tikiyapara, W/N- 28, SMC, PS- Siliguri, Dist- Darjeeling 2] Shyamal Biswasharma (36 yrs/M), S/O - Late Birendra Biswasharma, of Laketwon, W/N- 33, PS- NJP, Dist- Jalpiguri, 3] Rajib Mandal (36 yrs/M), S/O - Late Nirmal Mandal of Netaji para, near Ambedkar Sporting Club, Ghugumali, PS- Bhaktinagar, Dist- Jalpaiguri, 4] Arijit Das (33 yrs/M), S/O-Subodh Chandra Das of Satyajit Sarani, near 18 khai sarbajanin khelar math, Shivmandir, PS- Matigara, Dist- Darjeeling 5] Rabi Kami (35 yrs/M), S/O- Basnat Kami of Ujanu Shiv nagar, New Darjeeling More PS- Pradhannagar, Dist- Darjeeling before you under proper arrest memo and maintaining all formalities.

In this regard I, SI Sudip Saha presently posted as Siliguri PS, SPC do hereby lodge this complaint against the above noted five (05) arrested accused persons, Madhumita Saha of Ghogomali, W/N- 37, PS- Bhaktinagar, Dist- Jalpaiguri, Mahua Bose Tarafdar of Deshbandhupara, w/n- 29, SMC, PS- Siliguri, Dist- Darjeeling, Deep Nandi @ Kartick of Khaprail, PS- Matigara, Dist- Darjeeling, District Secretary of BJYM, Siliguri Zila Committee, Madhuri Mukharjee and approx 20 others unknown male & female supporters of BJP of Bharatiya Janata Yuba Morcha, Siliguri Sangathonik Zila to the effect that on 01.06.2024 at about 18.55 hrs about 40/45 supporters of Bhartiya Yuba started a demonstration programme before the main gate of Siliguri PS without any permission from Police Authority that causes obstruction of public road and free flow of traffic of the road in front of the PS under the leadership of above mentioned Arijit Das, President of Bharatiya Janata Yuba Morcha, Siliguri Sangathonik Zila and Madhumita, leader of Bharatiya Janata Yuba Morcha, Siliguri over the issue of assault of Sanjit Gupta, leader of BJP by unknown people in front Siliguri Municipal Corporation at the time of demonstration. They were carrying banner & flags of Bharatiya Janata Party (BJP).

Subsequently all the police officers and force available at PS cordoned the PS premises and politely prevent them to maintain peace and tranquility. Suddenly some of them got more furious and break the Police cordon. They forcefully break the main Iron Gate of the Siliguri PS, entered at the PS compound. Finding no other alternative we started to push them off and at the same time we directed them to maintain peace in the PS compound. But the unruly leaders and members of BJP did not pay any heed to our wards. They attacked on-duty Police personnel and broke the Police cordon under the leader ship of Arijit Das, President of Bharatiya Janata Yuba Morcha, Siliguri Sangathonik Zila and Madhumita, leader of Bharatiya Janata Yuba Morcha, Siliguri.

During agitation IC, Siliguri PS Shri Prasenjit Biswas, ASI Joydeep Dutta, ASI Nawaj Sharif got severe injury and they treated at Siliguri District Hospital. Some other police personnel also got injury from the agitation.

On reinforcement finally we detained some of them and arrested five (05) them maintaining proper arrest memo and informing them the ground of arrest. In the mean time other supporters of BJP started to leave Siliguri PS compound carelessly and aimlessly accordingly.
