I Sri Prasanjit Roy, S/o Late Pratap Roy of "Pushpanjali Apartment" Shivmandir, P.O. Kadamtala, P.S. Matigara, Dist- Darjeeling, do hereby lodge this FIR in the following way:-

That I am a Professional Driver and presently I am employed under Advocate Ramesh Kr. Agarwal as I am driving his Vehicle being No- WB 74 BK 2017 since last 3 years. The said vehicle my owner use to park at "Nilkamal Plaza" Hill Cart, Road, Siliguri for last 20 years with the permission of Developer of the Building named by "P.C. M. Group of Companies" represented by its Director Sri Niranjan Mittal. Three days back i.e. 28th May 2024 at around 7:30P.M. one of the shop owner named Sri Pradip Karmakar, proprietor of "Bidhan Jewellery" of the said Building raised objection regarding the parking of vehicle though there is no obstruction of parking of his vehicle at that time and the said person again abused me; but by the intervention of the others the matter was settled. BUT last night i.e. on 31-05-2024 at about 7.30 P.M. the said person again raised his voice again as and when I parked the said-vehicle and picked up quarrel-with me in filthy language regarding the same issue. At that time, I replied quietly gently but all on a sudden that person and his son by the name of Roni Karmakar pushed me and slapped me as a result of which I fell down on the parking area, hearing such cry and quarrel others owners of the said Building came out and tried to stop them. In the main time my employer Sri Ramesh Kr. Agarwal, Advocate and his staff Madan Dutta and Sri Abhishek Agarwal, Advocate, the son of Ramesh Kr. Agarwal came to the spot and rescued me. But at that time those persons abused my employer with filthy in language but by the intervention of the other shop owners we left the place at that I realized that my entire salary amount Rs.14,000/- has been lost from my pocket.
