- Most respectfully I beg to state that I,
Biswajit Sarkar, S/O - Lt - Nani Topal Sarkar of
Bagdogra Airport More, Machua patty (Subashpatty),
P.S. - Bagdogra, that on a civil case is ~~for~~
over a solid plot of land situated at Thikurikata
at as mentioned in the schedule of land, L.R. Plot No-296,
I.R. Chetan No-3171 (J.L. No-074) land measuring 0.8166 acre (2 Katha),
1. That on 19.03.24 an order ^{dt. 14.03.24 of Cr.P.} was given by the
Special Exe. Magistrate Court, Siliguri ^{in the} in the
petition case No-80 of 2022 (Order sheet enclosed)
herein.
2. That the recorded owner Rakesh Das and Pramab
Sarkar has duly appointed me as their power
attorney holder to carry on boundary construction
work at the said plot of land.
3. That on 01st June, 2024, when I was busy in
the construction work of the boundary wall then
at around 10:30 AM and the O.P.'s along with
8-10 persons entered into my said land and started
abusing me and using filthy languages and then started
creating disturbances and tried to stop the

said construction work along with their musketeers
6) That again I called visited myself Medical outpost
and along with Police personnel I went to the said
plot with them. Police on reaching the spot
restrained the O.P.'s and asked them to leave
the said land. The O.P.'s left the said plot
in front of the police personnel.
7) That after the police patrolling van left my
said plot again after 15-20 mins the O.P.'s
again entered the said plot and tried to
stop the construction work.

8) That the O.P.'s ~~are~~ namely Ujjal Bhadury, s/o -
Lt. Khokan Bhadury resident of Tribikata, P.O. - Sushru-
ta Nagar, P.S. Matigara, Dist. Darjeeling has tried to
restrain the construction work at the said plot
of land and around 8-10 persons were along with them
9) That the O.P. has also refused/denied to follow
Court's order and he has threatened
me with dire consequences to harm me
any possible way he can and gave life threats.

So, I am kindly requesting you to
look into the matter seriously and restrain the O.P.
to enter from the said plot of land and follow the
Court's order.
