I ,Pankaj Agarwal , S/O Sushil Agarwal, presently residing at Mayfair Garden, Maple View, Flat No 2E, Punjabi para, P.O Siliguri, District Darjeeling would like to inform you that in the year 2020 during the time of covid, my father Sushil Agarwal, S/O Late Rambilash Agarwal, presently residing at Mayfair Garden, Maple View, Flat No 2E, Punjabi para, P.O Siliguri District Darjeeling, was searching for a house maid for our house, when he came across a women (RUNA ROY, W/O MUNI ROY OF Prakashnagar, W.No. 43, Siliguri) who was willing to work as a house maid and before joining she told my father that she will ask her son whether he will allow her to work. Thereafter, as we got a domestic helper so later on he refused her to join our household work later few days she called up my father and asked for a financial help from him, for her daughter in law was not well, so he had helped her by paying an amount of Rs 15000/in cash. However on and off from time to time she started calling my father from her phone number 8167398658 and asked for financial help, and few times he helped her, but subsequently after helping for few times, he saw that it has become her habit to ask for money so he refused to pay her anymore. That thereafter she along with her son from the phone number 8167398658 started threatening him that he have to monthly pay her an amount of Rs 20000/- otherwise she will go and tell me and my sister that he had physical relation with her and this way she will defame him in front of his family and local people. He became very scared and tried to tell me but out of fear of social stigma he could not tell anyone and succumbed to their demand and every month since last three years she is taking money from him in mode of Cash & Bank , the said women provided him a account No. of Mangal Roy , SBI , Champasari Branch Account No 38197256332 over phone and told him to deposit the demanded amount in the said account as She stated him that due to some reason she is unable to come and collect cash from him, he had paid Rs 5000/- on 1st February 2024, Rs 5000 on 28th February 2024, Rs 8000/- on 5th March 2024, Rs 5000/- 12th March 2024, Rs 3000/- on 16th March 2024, Rs 7000/- on 16th April 2024, Rs 10,000/- on 22nd April 2024, Rs 5000/- on 15th May 2024, Rs 5000/- on 4th May 2024, to Mangal Roy through UPI payment from the account of our staff namely Shibsankar Baruli. That now the things have far stretched as she along with her son are demanding an amount of Rs 500000/- (Rupees Five Lakhs Only) from him stating that it is a one time settlement and he don't have to pay them anymore. That finding no alternative he had disclose about his situation to me, my family members advised me to seek police help and accordingly I am requesting you to look into the matter and book those unknown persons as the above two persons are regularly extorting money from him by putting him under fear.
