I Sabana Anjum, Wife of Md. Samim, resident of Qurashi Mohalla,  
Dangipara, Near Swastika Club, P.O. & P.S. Siliguri, Dist:- Darjeeling, begs to  
state as follows:-

1. That I have a son namely Ahmed Raza age about 24 years.
2. That my son along with his friends namely Aquib Qurashi and Mausam  
of above mentioned address went to a friend's house as there was some  
medical emergency at his friends house near thoker bridge today i.e.  
18/06/2024 at about 12:30 to 01:00 AM and after reaching there my son  
realized that his phones battery is running low and for the same he told  
his out two friends to stay there and he will come back in a while and my  
son went to get his mobile charger but on the way there was a railway  
crossing and a train was about to cross and for the same the road was  
blocked so my son again turned back to go to his friends house as it  
would take time for the train to come.
3. That while returning back to his friends house before the thoker bridge one  
person who is very famous for his illegal activities such as extortion,  
robbery, snatching etc namely **Jawed @Moun** along with his family  
members namely **Md Alam (brother of Jawed), Sabana, Ruksana,**

Nasima and also along with 4 to 5 people who was his (Jawed @Moun) friends who were standing before the thoker bridge and with deadly weapons such as iron road, sharp meat cutting chopper, etc which my son could see when my son reached near thoker bridge at around 01:00 to 01:30 AM Jawed @Moun hit my son with a sharpe cutting object on my sons forehead and while my son was riding my Activa Scooter being vehicle no. WB 74 AM 7702 after getting hit by the said Jawed @ Monu my son lost his senses/blackout for and moment and fell down when he regained his senses he saw blood oozing from his forehead after which all of the above mentioned people came and asked my son to give him his active keys and everything my son had with him or else they will kill my son to death out of fear my son gave him his wallet containing Rs. 1540 cash and few debit cards and he could also see a Police patrolling van in a distance and when they saw the Police van coming they run away from the spot and my son some how went to his friends house which was just near by and told his friends and then my son fainted there only after which my sons friends took him to the siliguri district hospital and was immediately admitted at around 03:30 to 04:00 AM and received 14 stitches and after this my sons friend informed me about my son being admitted in hospital.

4. That the above mentioned incident was narrated by my son to me today morning when I went to met him in siliguri District Hospital.
5. That I could not lodge the FIR in due time as I was in shock seeing my only son in such a horrible situation receiving such a gravies injuries and fighting for his life and I also did not knew the entire incident until today morning.

6. That my son is currently admitted in Siliguri District Hospital and is in a serious condition and have receives 14 stiches in his rightside forehead and further more reports are yet to come.
7. That the above mentioned peoples are repeatedly sending messages to us not to lodge any complain against them or else the consequences will be even worse.

I therefore request you to kindly take necessary legal action against the aforesaid culprits for the ends of justice as I and my entire family is in great fear.
