In producing herewith following four accused namely (1) Md. Chatu (25 yrs) S/o Lt. Md. Tafijul of Ashraf Nagar, Near Masjid, W/ No- 40, PS- Bhakti Nagar, Dist- Jalpaiguri (2) Lalit Tamang (34 yrs) S/O Subarna Tamang of A/P Prakash Nagar, Near Gandhi Maidan, PS- Bhakti Nagar, Dist- Jalpaiguri, P/A Bong Busty, Sabitri Ghising Road, PS- Kalimpong, Dist- Kalimpong (3) Sangam Saibo (27 yrs) S/o Lt. Prem Saibo of Majua Busty, Near Shib Mandir, PS- Bhakti Nagar, Dist- Jalpaiguri (4) Mithun Saha (24 yrs) S/o Niranjan Saha of Naresh More, Near Telipara Primary School, PS- Bhakti Nagar, Dist- Jalpaiguri with following seized articles viz:

- 1) One iron made sharp cutting knife and one iron rod (sabol) measuring 18 inches recovered from the exclusive and conscious possession of Md. Chatu.
- 2) One iron made 'Knife' and one torch light recovered from the exclusive and Conscious possession of Lalit Tamang.
- 3) One iron made weapon called as 'Bhojali' 14 inches recovered from the exclusive and conscious possession of Sangam Saibo
- 4) One small torch light and iron rod measuring approx 10 inches recovered from the exclusive and conscious possession of Mithun Saha

I, ASI Dipak Karmakar S/O Lt Dulal Karmakar of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above (1) Md. Chatu (25 yrs) S/o Lt. Md. Tafijul of Ashraf Nagar, Near Masjid, W/ No- 40, PS- Bhakti Nagar, Dist- Jalpaiguri (2) Lalit Tamang (34 yrs) S/O Subarna Tamang of A/P Prakash Nagar, Near Gandhi Maidan, PS- Bhakti Nagar, Dist- Jalpaiguri, P/A Bong Busty, Sabitri Ghising Road, PS- Kalimpong, Dist- Kalimpong (3) Sangam Saibo (27 yrs) S/o Lt. Prem Saibo of Majua Busty, Near Shib Mandir, PS- Bhakti Nagar, Dist- Jalpaiguri (4) Mithun Saha (24 yrs) S/o Niranjan Saha of Naresh More, Near Telipara Primary School, PS- Bhakti Nagar, Dist- Jalpaiguri and 9/10 others to the effect that today on 20/06/2024 at 00.05hrs received a specific source information that 13/14 miscreants have assembled at Dumping Ground under Bhaktinagar PS, Dist.- Jalpaiguri with deadly weapons. Accordingly, I informed the matter to the I/C, Bhakti Nagar PS and diarised the fact in General diary vide Bhakti Nagar PS GDE No 1435/24 dated 20.06.2024 and as per order I along with SI Youel lepcha, ASI Chandra Prakash Adhkari, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for dumping ground under Bhakti Nagar PS, Dist.- Jalpaiguri to work out the information in hand. At about 00.35 hrs we arrived at Dumping Ground under Bhakti Nagar PS, Dist.- Jalpaiguri as indicated by the source we noticed that 13/14 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach





towards the spot slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but somehow we managed to apprehended 04 (four) of them with deadly weapons in their possession but 9/10 persons managed to fled away from the spot taking the advantage of darkness and open place.

On interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that the following Pankaj, Jayanta, Guddu, Pinku and others were present there and making preparation for committing dacoity at Dumping ground area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest and brought them at Bhakti Nagar PS. The search seizure and arrest made on 20/06/2024 in between 00.55hrs and 01.45 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 04 (four) arrested accused persons namely 1) Md. Chatu (25 yrs) S/o Lt. Md. Tafijul of Ashraf Nagar, Near Masjid, W/ No- 40, PS- Bhakti Nagar, Dist- Jalpaiguri (2) Lalit Tamang (34 yrs) S/O Subarna Tamang of A/P Prakash Nagar, Near Gandhi Maidan, PS- Bhakti Nagar, Dist- Jalpaiguri, P/A Bong Busty, Sabitri Ghising Road, PS- Kalimpong, Dist- Kalimpong (3) Sangam Saibo (27 yrs) S/o Lt. Prem Saibo of Majua Busty, Near Shib Mandir, PS- Bhakti Nagar, Dist- Jalpaiguri (4) Mithun Saha (24 yrs) S/o Niranjana Saha of Naresh More, Near Telipara Primary School, PS- Bhakti Nagar, Dist- Jalpaiguri, 5) Pankaj, 6) Jayanta, 7) Guddu, 8) Pinku and others kindly arrange for its investigation
