Sir,

In producing herewith one arrested female accused person namely Sri Gopal Das (M-37yrs) s/o Late Dilip Das R/O Papiyapara Naresh More PS- Bhaktinagar, Dist.- Jalpaiguri along with the following articles under proper seizure list: -

- (i) 14 (Fourteen) sealed bottles of 'Himalayan Gold 60 UP' India Made Liquor each bottle containing 600 ml, i.e. 600 x 14 = 8400 ml and marked as "Exhibit-A". MRP Rs, 155/= out of which 01 (One) bottle taken as a sample and marked as "Exhibit -A-1".
- (ii) One polithin gunny bag content exhibit - "A"

I, ASI Prasenjit Barman S/O Late Sarat Chandra Barman of Ashighar OP under Bhaktinagar Police Station Siliguri Police Commissionerate would like to lodge this written complaint against the above-noted arrested accused person namely Sri Gopal Das (M-37yrs) s/o Late Dilip Das R/O Papiyapara Naresh More PS- Bhaktinagar, Dist.- Jalpaiguri to the effect that today on 20.06.2024 at 14.50 hrs. I received a reliable source information that one person is selling illicit liquor in his house at Papiyapara Naresh More under PS - Bhaktinagar, Dist.- Jalpaiguri without any valid license. Accordingly, the fact is diarized in the General Diary vide Ashighar OP GDE No 612, Dated 20.06.2024, and shared the information with O/C Ashighar OP and as per his kind direction, I along with force had been to Papiyapara Naresh More under PS - Bhaktinagar, Dist.- Jalpaiguri to verify the veracity of the information in hand. On reaching there and as identified by the source we held a raid in the house of accused Gopal Das and managed to apprehend him. On being asked he disclosed his identity as noted above and stated that he is selling illicit liquor at his house without any license for his wrongful gain. On further search, the above-noted seized articles were recovered from his house. On-demand he failed to produce any valid license/papers for selling and storing such articles. On further interrogation, he stated that he had been involved in selling and possessing liquor without any valid license for the last few months for his illegal gain. Then, I seized and labeled the above-mentioned liquor under the proper seizure list and arrested the above-mentioned person named Sri Gopal Das (M-37yrs) s/o Late Dilip Das R/O Papiyapara Naresh More PS- Bhaktinagar, Dist.- Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 15.05 hrs to 15.30 hrs.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against Sri Gopal Das (M-37yrs) s/o Late Dilip Das R/O Papiyapara Naresh More PS- Bhaktinagar, Dist.- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
