Respected Sir,

I, Sri Gagan Saiba, Son of Sri Asharu Saiba, resident of Mansarajote, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling, would like to lodge this complaint on behalf of my principal viz. Ajay Sunar, Son of Suresh Sunar against 1) Sri Rajesh Lama (Mobile- 9475919559), Son of Dal Bahadur Lama, 2) Sorna Minj Baraik, wife of Sakhilal Baraik, 3) Mariam Minj Baraik, Wife of Benadik Minj, 4) Anu Priya Minj and 5) Ankita Minj, both are Daughters of Benadik Minj, 6) Asit Minj, Son of Benadik Minj, all are residents of New Champta Tea Garden, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling.

Sir, my principal is the registered owner-in-possession of the land measuring 3.5 Katha or more or less 5.77 Decimal, recorded in L.R. Khatian No.- 2343, under L.R. Plot No.- 202, situated at Mouza- Jhouguri, in J.L. No.- 22, within P.S.- Matigara, Dist.- Darjeeling, by virtue of a registered Deed of Sale being Deed No.- 3481/2024.

Sir, since the date of purchase of the above land, my principal is using, enjoying and occupying the said land, by covering the said land with bamboo fencing and concrete pillar, as my principal is staying at Shilong, in the state of Meghalaya, taking the advantage of his absence, the aforesaid six persons in collusion and in connivance with each other and also with the direct instigation of Rajesh Lama, have come to the aforesaid land on the night of 18.06.2024 and completely uprooted all the fencing and also demolished the tin shaded temporary house structure, which was made by my principal and immediately seeing the same, when I went to the said land, the aforesaid persons have showered most abusive filthy languages towards me and also threatened me with dire consequences and also told that by hook and crook, they will capture the aforesaid land and if necessary, by killing the entire family of my principal.




