Dear Madam/Sir,

I, SMT. BACHHI SHA, wife of Sri Gandhi Sha, residing at North Mallaguri, Near Sree Guru School, Champasari, within ward No 46 of Siliguri Municipal Corporation, Post office - Champasari, Police Station - Pradhan Nagar, District - Darjeeling would like to inform you that today at around 12:00 PM while I was taking rest at home, my Daughter-in-law (1) SMT. SOBHA KUMARI SHA, wife of Sri Ram Pravesh Sha @ Munna Kumar Daughter of Late Ram Kishor Sha, (2) SRI ROSHAN SHA (3) SRI SURAL SHA, both sons of Late Ram Kishor Sha all are resident of Village & P.O -Sahiminapur, Police Station - Aurai, District - Muzzafarpur in the State of Bihar and (4) SMT. ANNU SHA, wife of Sri Sanjay Sha (Mob No. 97491-69446) resident of Near Sri Guru School, Tinpatti, Ward No. 46, Champaari suddenly came to my house shouting the name of my son with filthy languages and when they did not found him at home at that time they started assaulting me with fists and blows. My Daughter-in-law SMT. SOBHA KUMARI SHA caught me and started beating and/or assaulting me very brutally and mercilessly with fists, blows and kicks. She also kept slapping me constantly on my cheek and behind my ear from front and back side and also punched in my head by pulling my hair and while she were doing so she constantly kept on saying that she will kill me today while the other started destroying my house articles. When I tried to resist against their illegal acts and activities they became more furious and started threatening me to dire consequences by pressing my throat. When I started shouting very loudly to save my life then all of them ran away in fear and while running away my daughter-in-law SMT. SOBHA KUMARI SHA and SMT. ANNU SHA, wife of Sri Sanjay Sha snatched my gold chain from my neck and my gold ear rings from my ear. I tried to resist them but alone I was unable to do so and while doing this I fell on ground and at that time both of them dragged me very mercilessly by pulling my hair due to which I sustained injuries upon my hand and my eyeglass got broke. While they were running away I also tried to chase them but SRI ROSHAN SHA & SURAJ SHA pushed me inside

my house forcefully and locked the door of the house from outside. Sir/Madam due to such push and/or dash my cloth stuck somewhere and got tore amounting to breach of modesty. Thereafter I called my son over mobile phone and narrated the whole incident, he quickly came and took me to Siliguri District Hospital wherein I was diagnosed with blunt trauma, entire body pain, and swallowed cheeks with slap marks by the doctor and medicines were prescribed.

Madam/Sir my said daughter-in-law has left her matrimonial home (i.e., our house) in the month of January, 2024 and at that time also she left by abusing us with filthy languages and also stated that if my son do not shift himself separately at some other place and/or residential accommodation with her then we all shall have to face dire consequences.

Madam/Sir due to this illegal, act and activities and physical and mental torture by the aforesaid persons I am in deep shock and mental trauma and there is every chance and possibilities that they can do any illegal act and activities to end my life and the life of my son or any member of my family and as such I apprehend the threat to my life and liberty and the life and liberty of my son and/or family member, I therefore request you to immediately lodge this written complaint and start criminal proceedings against them and put the wrong doers behind the bars.
