Sir,

In producing herewith three (03) accused persons namely (i) Pronoy Mandal (28 yrs) S/O Pachu Mandal of Vill- Samar Nagar, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Rakesh Mandal (24 yrs) S/O Late Raju Mandal of Vill- Green Parak, PS- Pradhan Nagar, Dist.- Drjeeling and (iii) Ashim Sarkar (32 yrs) S/O Late Atul Sarkar of Vill- Samar Nagar, Dist.- Darjeeling under arrest and the following articles under seizure viz :- (i) One iron made sharp cutting weapon locally called as "Vojali" measuring 18 inch (approx) in length including its wooden butt recovered and seized from the possession of accused Pronoy Mandal (ii) one iron made weapon locally called as Khukri measuring approx 16 inch in length recovered and seized from the possession of accused Rakesh Mandal and (iii) One sharp cutting knife and one torch light recovered and seized from the possession of accused Ashim Sarkar. I, ASI Manoj Kr Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted three (03) arrested accused persons and their 06/07 unknown associates who involve in this crime to the effect that on 21.06.2024 at 00.10 hrs received a specific source information that about 08/09 persons assembled at below Mahananda river bridge near Parbati Ghat, Bagha Jatin Colony under PS- Pradhan Nagar, Dist.- Darjeeling equipped with deadly weapons and were taking preparation for committing dacoity at Bagha Jatin Colony and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 1069 dated 21.06.2024. As per your kind order and direction, at about 00.15 hrs. I accompany with ASI Biplab Kr Das, C/1169 Prasenjit Barman, C/1413 Sujit Sarkar, C/1119 Tamnoy Roy and C/1416 Dilip Barman all of Pradhan Nagar PS left for Parbati Ghat, Bagha Jatin Colony under Pradhan Nagar PS to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No. 1070 date 21.06.2024. On the way, I informed the matter to night RT van officer SI Bhiswadeb Barman and ASI Mir Rejaul both of Pradhan Nagar PS and requested them to come at near Parbati Ghat, Bagha Jatin colony to accompany with us for holding raid at below Mahananda river bridge near Parbati Ghat, Bagha Jatin Colony. At about 00.30 hrs we reached at near Parbati Ghat, Bagha Jatin Colony and after a while night van officers SO Biswadeb Barman and ASI Mir Rejaul along with RT Van force arrived at Parbati Ghat, Bagha Jatin colony and accompanied us. Then, I shared the information to all the members of raiding team and briefed them accordingly. Thereafter, I contacted with my source and as pointed by the source we noticed that 08/09 persons assembled in a dark place below Mahananda river bed near Parbati Ghat, Bagha Jatin Colony and they were whispering in a very low voice. We cordoned the place from both side with due care and caution. On seeing police personnel approaching towards them, they tried to flee away from the spot but on hot chase we managed to apprehended above noted three (03) accused persons with deadly weapons in their possessions while 06/07 others managed to flee away from the spot by crossing Mahanda river taking the opportunity of darkness. On interrogation, they disclosed their identities as noted above. On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with their associates assembled there and were making preparation for committing dacoity at Bagha Jatin Cololy and its surrounding areas.

Accordingly, I seized the above mentioned weapons of offence from their possessions under proper seizure list in between 01.15 hrs to 02.05 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. I accordingly brought all the three (03) arrested accused persons along with seized articles at Pradhan Nagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they along with their associates assembled there and making preparation for committing dacoity at Bagha Jatin colony and its surrounding areas.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted three (03) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night for taking preparation to commit dacoity in a nearby affluent area at Bagha Jatin colony and its surrounding areas.


Under the above circumstances, I therefore pray before you that a specific case under proper section of Law against may kindly be started against the above noted three (03) arrested accused persons namely (i) Pronoy Mandal (28 yrs) S/O Pachu Mandal of Vill- Samar Nagar, PS- Pradhan Nagar, Dist.- Darjeeling (ii) Rakesh Mandal (24 yrs) S/O Late Raju Mandal of Vill- Green Parak, PS- Pradhan Nagar, Dist.- Drjeeling and (iii) Ashim Sarkar (32 yrs) S/O Late Atul Sarkar of Vill- Samar Nagar, Dist.- Darjeeling and others 06/07 unknown miscreants and arrange for its investigation.
