Respected Officer,

I am Sanjay Agarwal, S/o- Sri Prem Kr. Agarwal, R/o- 'Gopikunj' opp. Hyderpara Market Complex, Sachitra Paul Sarani By Lane, Ward No- 40 of S.M.C., P.O. – Rabindra Sarani, P.S.- Bhaktinagar, Dist- Jalpaiguri, Pin – 734006, would like to register a F.I.R. against one of the driver (vehicle Bearing No WB-73 G 7059) of Municipal Corporation. That On 31.05.2024 I was involved in road accident caused by the reckless driver of a Municipal Corporation. The following accident occurred at approximately 11.45 a.m-12.00 p.m. Near Federal Bank, Sevoke Road. While I was riding my Scooty (Maestro), Vehicle Bearing No- WB-74 AB1962 and going towards Panitanki More, when the driver without any warning drove recklessly and collided with my vehicle.

As a result of the collision I sustained serious injuries to my right hand as it was bleeding with multiple fracture in fingers, which has caused me immense amount of pain and suffering. That soon after the accident my family members with the help of the local people took me to the nearest hospital for treatment. As my injuries were so severe that I had to visit another hospital namely – Star Hospital for better treatment. Due to this accident I am facing problem in my day -to-day life.

The driver's negligence and reckless behavior are unacceptable and such actions pose a significant risk to public safety.
