This is to inform you that I Md Ali Akhtar S/O Md Manir of Ashraf Nagar P.O. Haidarpore PS. Bhaktinagar D.T. Jalpaiguri

My wife (Najibuz Nisha) is the owner of one Blue Colour Tota. on 15/06/24 the driver of my aforesaid Tota was coming to our Residence at Ashraf Nagar from Check Post with 5 passengers at about 10.35 P.M. near check post one vehicle no - 00574 BK 0326 (Grey Colour Baleno) was asking for giving side to my driver at that time he could not give side due to jam then said Baleno started to chase my Tota and when it reached near P.C. Mittal at that time said Baleno driver Rishik Agarwall coming from wrong side in excessive and high speed intentionally dashed my said Tota from front side. my driver and 5 passengers got seriously injured and the Tota became fully damaged. The passengers of my Tota are admitted in Hospital and driver got stitches on his face and thereafter discharged from Hospital. I could not
