I Masuda Khatun (9933445373) resident of Gandhi Nagar, Siliguri would like to bring to your notice that I married Md Imran (9832685383) resident of Devidanga, Siliguri in the residence of Imam of Salugara Mosque which was officiated by Imam himself. The said residence is located near Garib Nawas Madrasa in Salugara. There were two witnesses present, Toukir (7584022239) and Salman Sarkar (7908756089).

Md Imran had made sexual advancements towards me prior to the wedding which I had denied. Upon my rejection, he asked me to marry him to which I agreed and later we consummated the marriage. A week after the wedding (21.06.2024) I was asked to visit a store in check post, 2nd mile where I was harassed by his family members which included his father, 7 brothers and his wife. They forced me to sign a legal document stating that our wedding is not valid. This said document was signed by Md Imran. Today (22.06.2024) I was verbally abused and threatened on a telephonic conversation by his brother Rezwana (9832014131) post my refusal to sign the forementioned document.
