With due respect I Smt Parul Paul, S/o. Sri Avijit Paul, resident of Milanpally, ward no.26(SMC), P.O.&P.S.Siliguri, Dt Darjeeling would like to inform you that I myself is the sole absolute and owner in possession of land measuring about 7 katha or 0.115 Acre recorded in Mouza Baramohan singh, J.L no.71 in plot no.869(R.S) corresponding to L.R plot no.1946, P.S.Matigara, Dt.Darjeeling by virtue of a registered sale deed being no.I-3911, dt.11.07.08 executed by Ashma Begam, wife of Late Md Mosaraf Hossain, resident of Chandbarjote, P.S.Matigara, Dt.Darjeeling. Subsequently one khatian has opened in to my name vide khatian no.6010 in B.L.&L.R.O Matigara Block. Unfortunately In the year 2023 the aforesaid khatian has been deleted by the B.L.&L.R.O Matigara Block and new khatian in the name of one Md.Badiojaman and 11(eleven) others has been opened in to their names. when I came to knowledge the aforesaid deletion of my khatian and opening new khatians in to 12 persons name I have raised objection in writing before B.L.&L.R.O Matigara Block and on basis of my objection the office issued Notice u/s 57 of W.B.L.R. Act 1955 to both the parties and also directed to be present today at about 12.00 noon .As per the direction of B.L.&L.R.O matigara block I myself with my only minor daughter and opposite party were present today before the concerned R.O and after ending the hearing one (1) Abdul Karim, Son of Late Md Safirul@Sonu, resident of Rabvita (Leausipukuri), P.S.Phansidewa, Dt.Darjeeling and (2) Md Safik, Son of Md Sarifuddin, resident of Chopramari, Kantivita under Uttar Bansaon Kismat, P.S.Phansidewa, Dt.Darjeeling chased me and my minor daughter outside the B.L.&L.R.O office that why I had lodge complain before the office against them then I have answered my bonafide khatian has been deleted and new 12 khatians has been opened in the name of your father and relatives collusively that is why I have lodge this complain. Instantly they became very furious and started filthy languages to us when

I raised vehement objection they pushed me and my minor daughter as result we fell down on the road thereafter they used fist blows and kicks also disrobe my worn saree for the purpose of molestation. After listening hue and cry local public gathered there and that time they fled away with dire consequences.

In this above circumstances I am running my days with full of danger and misery with my only minor daughter that is why I am requesting you to please nab the accused persons immediately from my kind perusal.
