

He was hit by a rash driving car (23BH 7011 A) from backside while he was walking on the roadside of Nepal More, Deshbandhupara on 21.06.2024 at 5:45 pm (approx). In this accident, he received grievous injury on his head and is currently under ventilation/ICU at Thalamus Institute of Medical Sciences Pvt. Ltd., West Shantala, Fulbari, Siliguri.
