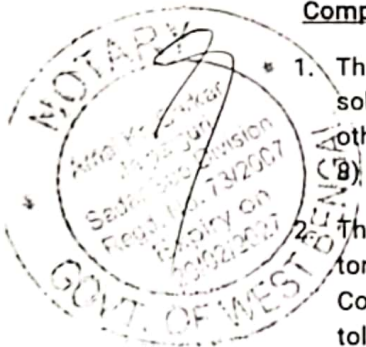

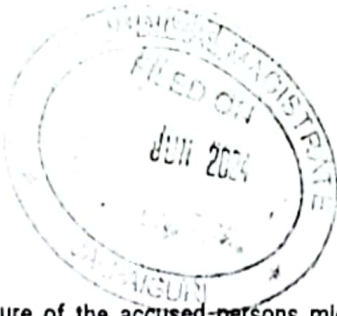

DATE, TIME AND PLACE OF OCCURANCE- On 30.03.2024 at about 10 pm at the matrimonial house of the complainant and on 13.05.24 at about-6 pm on the way near at NJP Police Station area.

Complainant filed the petition U/S-156(3) Cr.P.C on the following reasons/ground-

1. That the complainant is married wife of the accused No-1 and their marriage was solemnized since before 13 years ago by observing Hindu Rites and Customs. All other accused persons are her inlaws(2,3,5 and 7) and son of her inlaws(4,6 and 8) and last one is a relative of accused persons(9).
2. That one year after marriage, the accused No-1 and accused No-2 started torturing the Complainant physically and mentally. They threatened to kill the Complainant. Even they assaulted the Complainant. The Complainant used to tolerate the same without disclosing anyone and tried to continue the relationships with a hope





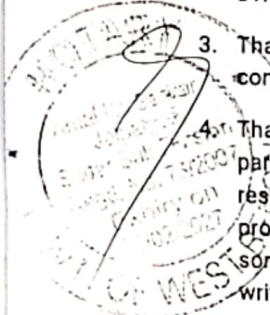

that one day the nature of the accused persons might be changed and they would stop torturing her but no fruitful result. The torturer upon the complainant was increasing day by day at mountain high. Finding no other alternative the complainant earlier on 14.05.21 lodged a written complaint against them and on the basis of same a criminal case was initiated against the accused persons. That after the aforesaid incident the accused persons took the complainant with them with an assurance that in future they would not inflict any kind of torture upon her and believing the same, she went with them and the complainant once again started to live at her matrimonial house peacefully for some days. But after few days the complainant found herself in same kind of atmosphere. The accused No-1 and 2 started torturing the complainant as like earlier. That on 30.03.24 without any cogent ground accused No-1 and 2 started abusing the Complainant with filthy languages. They intentionally created such atmosphere to turn the Complainant out from their house. Accused No-1 started beating her. Accused no-2 threatened to kill her. Finding no other alternative, she called his father and her mother over phone and getting the information, at about 11 pm the father, mother and brother of the complainant arrived at the matrimonial house of the Complainant. At that time accused persons No. 2, 3, 4, 5, 6, 7, 8 and 9 gathered at her matrimonial house and all the accused persons together assaulted the father, mother and brother of the complainant, her father was hit with a lathi. On account of that assault her father got serious injuries and started hue and cry. The complainant somehow rescued her father from the hands of the accused persons and from there she took her father at Siliguri District Hospital for treatment. Thereafter they went at Radha Krishna Pally that is at the house of her father under Bhaktinagar Police Station, Dt- Jalpaiguri. On next day that is on 31.03.24 the complainant went to the NJP Police station to inform the matter in writing but the Police personnel of NJP Police Station refused to take the complaint. Finding no other alternative the complainant informed the aforesaid matter to the Commissioner of Police, Siliguri police Commissionerate on 31.03.24. But no case was initiated against them.



3. That during this time the accused persons did not take any initiative to bring the complainant back at her matrimonial house.
4. That on 13.05.24 at about 6 pm when the Complainant was returning to her parent's house then on the way near NJP Police Station area the Accused No-1 restrained her and started abusing her with filthy languages. The Complainant protested, resulting she was assaulted by the accused No-1. The complainant somehow escaped and went to the NJP Police Station to inform the matter in writing but as earlier they refused to take the complaint from the complainant.
5. That NJP Police Station did not take any action against the accused persons. Neither the said NJP Police Station enquired the matter nor start a specific case against them.
6. That the aforesaid matter was also informed to the Commissioner of Police, Siliguri Police Commissionerate on 14.05.24 but no fruitful result, neither any direction was given by the Commissioner of Police, Siliguri Police Commissionerate to the NJP Police Station to start a specific case against the accused persons nor any direction has been given to enquire the matter.

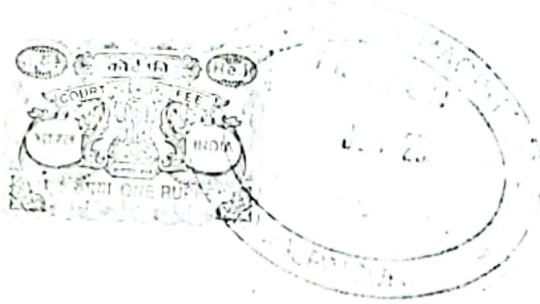

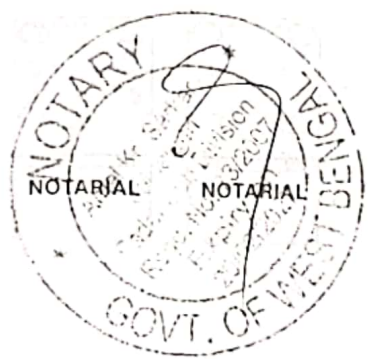
