Respected Sir,

I, **SRI. SUBHOJIT GHOSH, S/O SRI DULAL GHOSH, PROPRIETOR OF PURNIMA CAR CARE**, residing at Shaktigarh, Road No. 3, Ward No. 31, P.O. Siliguri Bazar, P.S. NJP, Dist - Jalpaiguri, Pin - 734005, W.B. from the year of 2021 connect with Sevoke Motors Pvt Ltd situated at Salugara 2nd Mile, Sevoke Road, Siliguri, Dist - Jalpaiguri, W.B. owned by **SRI NARENDRA BERLIA** as Washing Vendor and Car Service Provider. From the beginning I have done my work with full sincerity and determination towards the said company and 15 to 25 members are works under my supervision and from beginning I told them repeatedly to make an agreement regarding my work related with washing and vehicle service but they denied to doing and make deduction as Rs. 500/- per vehicle and only pay Rs. 120/- to my client per vehicle and all machinery expenses had to bear by my client which was not supposed to do. It is also mention that since my joining in the said company I have suffered losses (which bills are with me) and then the **SRI NARENDRA BERLIA (CEO OF SEVOKE MOTORS PVT LTD)** and **SRI SUSHIL MODESHIYA (GENERAL MANAGER)** assured me to compensate me and by good faith, trust on them I continue my work but no necessary steps did not take by the said persons till yet. Further they try to repulse me from the said company without clearing my losses which they had assured me on earlier occasions also. Thereafter continue pressure comes from their side to repulse me and for that I was compelled to pay a extortion amount of Rs. 1,71,300/- (Rupees One Lakhs Seventy One Thousand Three Hundred) only to **SRI GOUTAM DAS** (True Vaive in charge) and **SRI SUSHIL MODESHIYA** (General Manager of Sevoke Motors Pvt. Ltd.) in different dates of months in the year of 2022 to 2024 to them.

Now recently in this month they tried to expel me from their company by showing some lame excuses and continuously put pressure upon me and manipulate my work members to not work with me by not clearing the monthly payments with the losses which I have incurred. Ultimately on 12/06/2024 I send a lawyer's notice through E-mail and Whatsapp to them regarding my losses, monthly payments and the said money which has been extorted by them and for that I could not pay salary to my members accordingly. After that on the same day the said CEO of Sevoke Motors Pvt Ltd Sri Narendra Berlia called me over phone to meet with him at his companies premises and I go with my lawyer to met with him for coming in a solutions, but he did not even listen my problems, further he threaten me to not to pay anything and remove from his company then and there. Thereafter On 18/06/2024 the said **GENERAL MANAGER SUSHIL MODESHIYA** discuss with us and assured us to clear the said extortion money of Rs. 1,71,300 but they tried to pay Rs. 1,20,000/- as full and final settlement and also told me to give NOC regarding my Lawyer's Notice by waiting till 11 p.m. and when I refused to do that then they threaten me to lodge false cases against me and my members, which they are still trying to do continuously for repulsed me from their company without giving monthly payments, losses amount and the said extortion money.

So, it is therefore humbly prayed to you that kindly take strong action against the above named person as early as possible.
